## ÉCONOMIE INTERNATIONALE (International Economics and Sustainable Development)

### PROGRAMME OBJECTIVES

The Master's of International Economics (specialization International Economics and Sustainable Development) accredited by the University of Orleans, offers a 2-year programme of excellence (M1-M2). It is taught entirely in English.

This is a unique Master's level programme in the Centre Val de Loire region that covers a wide range of international economics topics (such as trade, open macroeconomics, development, and international finance) combined with courses in applied econometrics and environmental and resource economics.



### MAIN ADVANTAGES OF THE PROGRAMME

- > The Master's programme is held at the Faculty of Law, Economics, and Management of the University of Orléans. It is supported by the Orleans Economics Research Centre (LEO), which gathers professors, associate professors, and researchers from the University of Orleans, the University of Tours and the University of Clermont Auvergne. The programme is connected to the LEO International Economics and Sustainable Development (EI2D) research team.
- > The programme is taught by professional field experts, foreign professors (e.g. University of Geneva, University of Darmstadt, Zeppelin University), and by LEO specialized professors in international economics and sustainable development.
- > Its tight interconnection between theory and application helps students meet employers' expectations, particularly those looking for international economics analysts with a background in data analysis and environmental economics; it helps students acquire solid skills concerning the international environment and sustainable development by the time of their graduation.
- > This English-only programme meets the requirements and expectations of businesses, institutions, study centres, and national and international research centres. It is characterized by a strong international collaboration that brings together foreign students, partnerships with international organizations (i.e., IMF, World Bank, OECD) and with several foreign universities (i.e., the universities of Bucharest, Texas, Göttingen, Kiel, Namur). Also, the programme is characterized by a strong international presence in the Master's Steering committee (with representatives from the universities of Rome La Sapienza, Henan, or College of Europe). The students in this Master's programme will have the opportunity to study one semester abroad, at a partner foreign university that signed Erasmus + agreements with the University of Orléans (more than 60 agreements in Economics are currently available) or special partnerships (with universities in Tunis, or Coimbra).



> A key objective of this Master's degree is also to select BAC+5 students and help them pursue their doctoral studies. Fifteen of our graduates have gotten enrolled in doctoral programs at the University of Orléans or other universities (e.g. University Paris Saclay)

## INTERNSHIPS

> An optional internship of up to 3 months can be performed at the end of the 1st year of the Master's.

> A 4 to 6-month mandatory internship is required in the 2nd year and is subject to an evaluation. This internship can be completed in or outside of France.

## TYPES OF PROFESSIONS AND OCCUPATIONAL INTEGRATION

The Master's programme will help the students acquire the theoretical and practical tools necessary for working in an international economics and business environment. In the second year of the Master's program, students can choose between the professional and the research paths.

Graduation in the Master's professional track offers the following career opportunities: Economist, Country risk analyst, Project manager, Consultant, or Data analyst.

> In the private sector: exporting firms, or multinational companies from manufacturing and service sectors, consulting companies, commercial banks, international logistics and transport companies.

> In public or mixed public-private administrations: rating agencies, ministries, and other related departments involved in trade, finance, sustainable development, environment, or international affairs.

> For non-governmental organizations (NGOs) involved in trade, aid, sustainable development, education, or environmental programs.

Graduation in the Master's research programme offers the following career choices:

> Specialist in international economics and sustainable development in international organizations (e.g. OECD, World Bank, IMF, European Commission), regional/national study centres, ministries.

> Lecturer/Associate professor (teaching and research) in universities or business schools

> Researcher (e.g. INRAE, BRGM, CEPII, other research centres in France and abroad)

Professional integration is facilitated by:

> Privileged relationships with multinationals (Renault, Orange), banks (Crédit Agricole, HSBC, Société Générale), local partners (Orléans métropole, Lab'O), exporting firms (Vignoblexport, International Electric Export), as well as national organizations (Banque de France, CEPII) and international institutions (African Development Bank, World Bank, European Commission, IMF).

> The existence of a strong network of professionals delivering specialized courses offered each semester.

> The Development of numerous professional projects set up in relation to specialists in the field. Conferences and seminars are organized each semester to allow students to get further opportunities to meet professionals in the field.
